### **Seasonal Locker Policies:**

- Any misuse of locker or locker room will result in forfeiture of locker privileges.
- Lockers are rented as is, Bigrock Mountain must approve all alterations in advance
- Lockers are rented on a seasonal basis, all contents of the locker must be removed on or before the closing date of current season unless payment has been received by April 31st for the 16/17 winter season.
- Failure to remove contents before the closing date will result in a \$10 re-occurring monthly equipment storage fee.

## 2016/2017 Winter Seasonal Locker Rental Release of Liability and Agreement

In Consideration of being permitted to use the rental locker and locker room area of Bigrock Mountain, I agree to RELEASE, INDEMNIFY, DEFEND AND HOLD HARMLESS Bigrock Mountain, its parent, subsidiary and affiliated companies and their respective agents, officers, directors, real and personal property owners, contractors, volunteers, employees and insurers (collectively, the "Releases") from any and all claims, losses and damages I might bring as a result of injury, property loss and/or damage of any kind sustained in connection with my use of Bigrock Mountain's rental locker, locker room, and premises. I am fully responsible for any and all loss, damage or injury of any kind that may result from my use of the rental locker, premises and facilities. I promise not to bring a claim against or sue the Releases in connection with any matter relating to my use of Bigrock Mountain rental locker, premises and facilities. I FULLY UNDERSTAND AND AGREE THAT THE RELEASEES ARE NOT RESPONSIBLE IN ANY WAY, FOR LOSS OR DAMAGE TO ANY PROPERTY THAT I MAY STORE IN THE LOCKER OR MAY LEAVE IN THE LOCKER ROOM.

I understand that my seasonal locker is the property of Bigrock Mountain and I agree to and understand that the contents of my locker are required to be removed on or before the closing date of the 2016/2017 ski season. Failure to remove contents on or before the season closing date will result in a \$10 re-occurring monthly equipment storage fee unless renewed for the following winter season by April 30th. I understand that my seasonal locker is non-transferable any may not be subleased to a third party. In the event that an item contained within my locker is lost or stolen, I will notify the Ticket Office/Rental Shop immediately. I understand that I may be charged for damage arising in connection with my use of the locker. I understand that permission to use Bigrock Mountain premises, facilities and equipment is being given to the undersigned participant in exchange for the execution of this Release of Liability and Agreement. I freely and voluntarily enter into this agreement. I intend this document to be interpreted as broadly as permissible by Maine Law.
